# Who are sovereign citizens?

---

- Far-right extremists; anti-government
- Openly reject their citizenship status and claim to exist beyond the realm of government authority
- Estimated to be approximately 300,000 in the United States
- Roughly 100,000 are considered dangerous “hardcore extremists” while the other 200,000 are testing the waters



# Who are sovereign citizens?

---

- Also located in Canada and Great Britain
- No central leadership or organized group
- Known local leaders in some communities
- Share ideas and documents via internet or seminars
- Courses you can purchase online
- Do it Yourself Credit Card, Secured & Unsecured Debt Elimination, Redemption Program & More” - \$1,500



# How to identify them

---

- Refer to themselves as a “Sovereign Citizen” in the USA or a “Freeman” in Canada.

*As “sovereign citizen” develops a negative connotation, some are rejecting this term, but still hold the same beliefs.*

- Often sign their name as an agent of themselves:

*“**John Doe**,, Executive Trustee for the Private Contract Trust known as JOHN DOE ©”*



# How to identify them

- Will add words or punctuation to their name
  - ✓ Specifically: Nobel, Bey, El Bey
  - ✓ “john; doe” which separates the Christian name, “John”, from the government-given name of “Doe”.
  - ✓ The use of lower case letters for the entire name separates blood and flesh person from government created strawman/corporate being.



# How to identify them

- Use of fake driver's licenses or license plates that do not reference a valid U.S. State. Even fake passports.





# How to identify them

- References to the federal Uniform Commercial Code
- Specifically UCC 1-308 (relating to commerce and contracts)
- References to UCC 1-207 which is the predecessor to 1-308.

# How to identify them

---

- May sign “Sui juris” after their name. (Latin for “of one’s own right”)
- May sign “without prejudice” or “as agent of” or will simply use numerical options.



# How to identify them

---

## Buzzwords

- Strawman, UCC, Sui Juris, State Citizen
- Non-resident alien
- Redemption
- Title 4 flag
- Silence is acquiescence
- Negative averment
- Zip codes that include [brackets] or “near”
- Will not use normal city/state addresses
- Indigenous
- Conveyance
- Affidavit of truth, Authentication of Authority
- In Admiralty



# What do they believe?

---

- They believe they have two distinct identities
- They have a personal or birth identity which is their flesh and blood identity
- They have an identity the government gave them using birth certificates known as their corporate identity



# What do they believe?

---

General belief system:

- They are not subject to the laws of the Federal, State or Local governments, nor are they required to pay any form of tax
- Certain constitutional amendments are invalid
- Banking practices are often illegitimate and unenforceable
- Birth Certificates are a “legal fiction”
  - **A presumption of fact assumed by a court for convenience and it is something accepted with no proof.**



# What do they believe?

- Governing law
- US Congress no longer exists



# What do they believe?

---

President Lincoln assassination:

- On March 27, 1861, while Lincoln was president, 7 states left the Congressional session
- No quorum to vote or to set a time to reconvene
- Result was no government
- Lincoln used an Executive Order to call the states back into session
- Executive order was never ended as Lincoln was assassinated
- We are still functioning under Martial law and Congress is a “legal fiction”



# What do they believe?

- Because we are still under martial law, courts are “Special Admiralty”
- Gold-fringed flags in courtrooms



# What do they believe?

---

- The government uses birth certificates and social security numbers as collateral to take on more debt
- Result of the United States no longer being *gold standard*
- Birth certificates create a trust account in the child's name and fictional person also know as a strawman, shell person or corporation
- Names on birth certificates are in all caps thus creating a legal fiction
- Each trust account may have \$600,000 deposited at the time of birth



# What do they believe?

---

- Redemption: an opportunity to cure
- The process of separating the legal fiction or corporate shell from their own *flesh and blood human self*
- This takes the flesh and blood human self outside of the jurisdiction of the United States laws, and particularly the tax code
- This is how they access the secret trust fund the government created in their name at the time of birth
- By filing a UCC1 financial statement to establish their right to the account and to create bonds to use as tender to pay off debts
- If creditors refuse to accept this form of tender, they consider the debt discharged



# What do they believe?

---

## Opportunity to cure

In the event that “RESPONDENTS” failure to respond sufficiently to the NOTICE OF TENDER FOR SETOFF and REQUEST REGARDING A STATEMENT OF ACCOUNT was an oversight, mistake or otherwise unintentional, ●●●●, (Claimant), grants “RESPONDENTS” three (3) days, exclusive of the day of receipt, to cure the fault. Failure to cure will constitute, as an operation of law, “RESPONDENTS” final admission and agreement to all statements and claims made by Claimant through *tacit procuration* pertaining to NOTICE OF TENDER FOR SETOFF and REQUEST REGARDING A STATEMENT OF ACCOUNT and the whole matter shall be deemed *res judicata and stare decisis*. # What do they believe?

- Bible

- ✓ They are subject only to the moral laws of the Bible
- ✓ It appears they will agree they are subject to certain Constitutional laws, common laws, UCC regulations, intellectual laws (trademark/copy rights) and others laws they can use to their benefit



# What do they believe?

- They are intrigued by the notion of easy money, living a lawless life, free from consequences or taxes.
- When they experience a small victory, they are encouraged to continue and tend to flaunt even the smallest win.



# Training staff to interact with sovereign citizens:

---

Sovereign citizen mantra is intended to rattle you, be nonreactive.

DO NOT:

- ✓ Get pulled into a battle of wits based on sovereign rhetoric.
- ✓ Engage in argument or debate policies or procedures.
- ✓ Become aggressive.
- ✓ Sign any documents given to you by them.

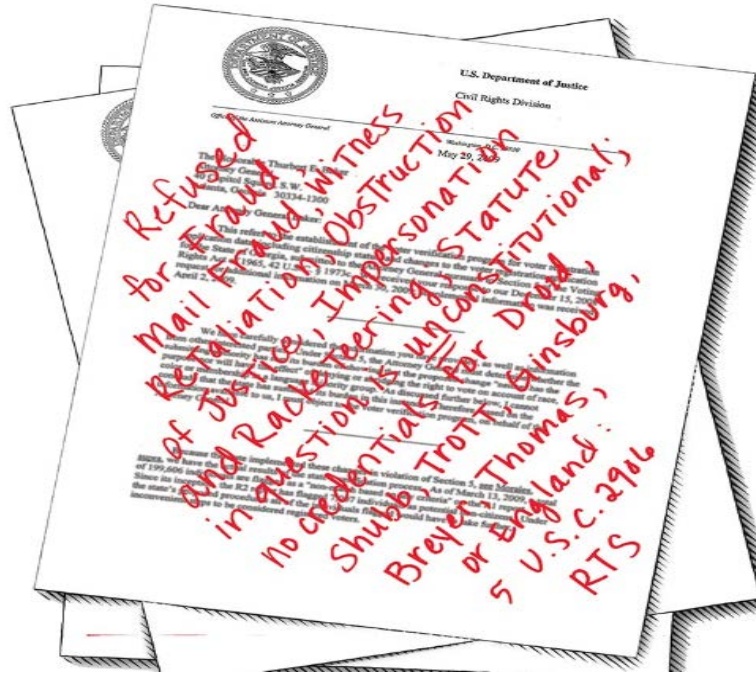


# What do they do?

While law enforcement face a much more hands on and physically aggressive type of danger, attorneys are primarily terrorized by massive amounts of paperwork that they receive personally or from court filings.

# What do they do?

---

- They have been known to file false liens.
  - In response to several Judges having liens filed against their homes, some years ago, several states passed laws that make it a felony to file fraudulent liens against public officials or employees.
  - Liens often are not discovered until the victim attempts to sell their property.



# False Liens

---

- Michael School refused to pay his electric bill, which he called a monthly extortion fee. This led to his demand that the PG&E remove all meters within 400 yards of School's home
- He then demanded daily damages from the sheriff and PG&E, payable in silver
- When he didn't hear back from the power company, he filed a \$15,000,000 lien against the power company



# False Liens

---

- In 2013 a Minnesota Department of Corrections Commissioner was forced into personal bankruptcy due to sovereign legal filings
- In 2016 Iowa Department of Transportation worker was sued for \$6 million by sovereign
- In 2017 Colorado sovereigns threatened public servants with criminal complaints unless they resigned
- In 2017 sovereign filed a lien against a family who purchased his mother's home



# False Liens

---

- Most states make filing a false document a crime only if they file against a public servant with retaliatory intent.
- Michigan, West Virginia, New jersey, Nevada, Arkansas and Florida all cover current and former federal, state, and local officials in some capacity.
- Some states have passed legislation to try and prevent paper terrorism rather than make it a crime.
- Colorado, Utah, Ohio, West Virginia, Mississippi, Florida and Virginia allow clerks to reject filings that look fraudulent.
- Iowa, Nebraska, North Dakota and Idaho allow clerks to reject a filing by any person who names themselves as the debtee and debtor.



# False Lien Fines

---

- West Virginia: First offense no less than \$100, no more than \$1000; subsequent offense up to \$10,000
- Tennessee: up to \$3000
- Georgia: up to \$10,000
- Louisiana: “Whoever commits the crime of filing a false lien against a law enforcement or court officer shall be fined not less than \$500 nor more than the amount of the value of the false lien or encumbrance.”



# What do they do?

---

- They file extremely long court documents filled with nonsensical language.
  - Will file hundreds of documents in effort to fight minor things like parking tickets, pet registrations, or driving without a license.
  - Often the cases are dismissed as it just isn't worth the time and cost to prosecute. But even if the case is dismissed without prejudice, they celebrate on-line and offer suggestions to others on how to win their own cases.



# What do they do?

---

- Their nonsensical language is specifically intended to confuse you.
- They draft notices in ways that if not responded to, will be considered agreed to.
- They argue that a “notary” is an officer of the court, and can act as a judge, bailiff or lawyer. So when there is no response to a notary stamped document, they believe there is consent for the document to become a court order.



# What do they do?

---

- They use nonsensical language, especially in the courtroom
- They feel their consent is required for the judge to have jurisdiction over them.
- They feel that agreeing to be called by their legal name is equal to consenting to the court's jurisdiction
- They believe that entering the courtroom area or standing when addressing the judge equal to consent
